Making PDFs accessible

PDFs or Portable Document Formats are a really popular file format. It's a system that allows the document owner to lock down the content and designs, protecting them from being changed or plagiarised. For many organisations a PDF is an ideal way of sharing factsheets, guides, white papers, reports, newsletters or product manuals.

PDF was originally created so that files could be transferred between computers and operating systems for printing, but as our digital habits have changed with the introduction of tablets and smartphones, we're increasingly using PDF as the end format.

What many people don't know is that PDFs can be inaccessible to disabled people, particularly those with a visual impairment or a learning disability such as dyslexia. If a PDF is not designed in the right way, someone using a screen-reading device or the voiceover command might not be able to access the content.

Tips for creating an accessible PDF that can be read aloud

- PDFs are created from a source document, usually in another programme such as Word or PowerPoint. The best chance of making your end document accessible is to start with an accessible source document.
- The original document needs to be 'tagged' when it is converted into PDF.

 By tagging the content you are giving the document a structure or hierarchy,

 which becomes the basis of a PDF tag tree something that allows

 assistive technologies to navigate your content.
- The styles, features and headings in Microsoft Word help you format your content and give the document a structure. A well-structured original document is the best starting point for creating the PDF tag tree.
- If you are creating a list of content, use the list styles in Word and use a numbered list sequence if there is a specific order the content follows. If your document is several pages long then use the table of contents function to create a contents page.
- Layout and formatting use left aligned text and choose a sans serif font such as Arial, Helvetica or Calibri. The minimum font size recommended is 12pt. If you need smaller text in footnotes or endnotes increase the body text size to 14 pt.

- For emphasis in a text use **bold font** (but use it sparingly) and don't use *italics*, UPPER CASE, or <u>underlining</u> as it makes the text harder to read.
- Use of colour The colour contrast between foreground and background colours needs to be strong enough and comply with the <u>Web Content</u>

 <u>Accessibility Guidelines (WCAG 2.1)</u>. Make sure you avoid using colour alone to convey meaning and include a text description or label as well.
- 8 If you have a lot of data included in your document use data tables with proper column headings to display it.
- 9 Use of images Make sure you include a text description of all the images in your document. If the image conveys meaningful information, the text description must contain the same information.
- Avoid using too many acronyms and abbreviations and wherever possible, include the full version on each page the first time the acronym appears.
